The Government of Liberia, Ministry of Agriculture (MOA) has received a loan from the International Fund for Agricultural Development to finance the Smallholder Tree Crop Revitalization Support Project (STCRSP). A portion of the loan will be applied to eligible expenditure for specific road rehabilitation works in Lofa County. The Ministry of Agriculture, through its Program Management Unit, now invites sealed bids from eligible bidders for the construction of the following roads:

2. To be considered responsive for the lot, a bidder shall quote for all items in its required quantities. Bidders who do not quote for all items under the lot will be rejected as incomplete. Bids will be evaluated and contract awarded to the lowest evaluated responsive bidder.

3. Bidding will be conducted using the National Competitive Bidding (NCB) method.

4. Bidding is opened to all contractors who hold Ministry of Public Works Contractor Classification Certificates (CCCs) with a Minimum Certificate of Class (A1 & A6).

5. Interested bidders may obtain further information and inspect the bidding documents at the address below between 9:00 A.M – 3:00 P.M. Bidding documents may be purchased upon payment of a non-refundable fee of USD50.00 at the Project Implementation Unit, Program Management Unit, Ministry of Agriculture, University of Liberia Campus, Fendell

6. Bids must be delivered to the address below on or before Friday November 4, 2016 at 10:00 A.M. All bids must be accompanied by:

- Bid Security as indicated above
- A copy of a valid business registration certificate
- A copy of an updated tax clearance;
- A copy of the Ministry of Public Works classification certificate- Class (A1& A6)
- An updated statement of account from an accredited bank with which the bidder has savings
- A list of recent contracts performed (at least two similar works) with evidence of completion.

7. Site visit is scheduled for October 19 to 21, 2016 at 8:00 AM and will be led by a representative of the STCRSP-IFAD/MOA. Site visit is mandatory. Pre-bid Conference is scheduled for Friday October 28, 2016 at 2:00 P.M in the main Conference Room of the Program Management Unit, University of Liberia Campus, Fendell. All bidders are encouraged to attend the pre-bid conference.

8. Bids will be opened on Thursday, November 4, 2016 at 10:00 A.M. in the main conference room of the Program Management Unit, Ministry of Agriculture, University of Liberia Campus, Fendell, in the presence of bidders/ bidders' representatives who choose to attend.

9. Alternative Bid will not be accepted. Late bids will be rejected and returned unopened to bidders.
