### NATIONAL COMPETITIVE BIDDING

1. This Invitation for Bids follows the General Procurement Notice for this Project that appeared in *Development Business*, with **Reference No. AFDB80-05/12** posted **11th May 2012**.
2. The Government of Liberia is implementing a project with grant resources from the Global Agriculture and Food Security Program (GAFSP) and a loan from the African Development Fund toward reducing rural poverty and household food insecurity by increasing income for smallholder farmers and rural entrepreneurs particularly women, youths and the physically challenged. The Government of Liberia intends to apply part of the proceeds to payments under the Contract for the **Supply of Fertilizers, Herbicides, Insecticides, Fungicides, Cassava Cuttings and Soil Nutrient Scanners in Contract No: LIB/SAPEC/PMU/GC/NCB/001/2020**.
3. The Program Management Unit (PMU) of the Ministry of Agriculture now invites sealed bids from eligible and qualified bidders for the **Supply of Fertilizers, Herbicides, Insecticides, Fungicides, Cassava Cuttings and Soil Nutrient Scanners in 3 Lots** as indicated below:

**4.** Bidding will be conducted through **National Competitive Bidding (NCB)** in accordance with the African Development Bank's *Rules and Procedures for Procurement of Goods and Works* (May 2008 Edition, Revised July 2012) and is open to all bidders from eligible Regional and Non-Regional member countries, as defined in the Guidelines.

**5.** Potential Bidders are permitted to submit bids for one or more lots which will result in independently separated contracts per Lot.

9. Partial bids are unacceptable. Interested bidders are to bid for a complete Lot. Awards will be granted on a complete lot basis.
