Main Duties

The Animal Health Project Officer will coordinate the planning and implementation of animal health activities to ensure timely and effective implementation of REDISSE activities under the context of One Health to strengthen surveillance, laboratory systems, emergency preparedness and response, and workforce.

The Ministry of Health now invites eligible (“Individuals”) to indicate their interest in providing the services as per the below qualification requirement.

Qualifications and Requirements:

The minimum qualification and requirements for the position are:

- Holds a Master’s degree in agriculture, public health nursing, social science, environmental health and DVM epidemiology.
- Have a solid professional experience of at least 3 years in veterinary and/or para program and knowledge of OIE Strategic Interventions and country animal health priority diseases
- Must have relevant work experience and technical capacity working in animal, human and environmental health diseases surveillance and/or events
- Have the capacity for sound communication and community entry/engagement skills
- Strong knowledge in agriculture services, veterinary and/or para-vets services, social sciences and related fields with capacity in technical documentation (development of work plan, budgeting and produced meeting minutes)
- Deep understanding of fieldwork in the areas of animal and environmental health
- Have the capacity to work in Microsoft (Word, Excel and PowerPoint).
- Excellent English writing skills and

- Ability to meet tight deadlines and to work effectively under pressure, including in a multicultural environment
