Consulting Services: CONSULTANCY TO CONDUCT KNOWLEDGE, ATTITUDE AND PRACTICE (KAP) ANTIMICROBIAL RESISTANCE (AMR) BASELINE SURVEY

The Government of Liberia has received financing from the World Bank in support of the Regional Disease Surveillance System Enhancement (REDISSE –II) Project and intends to apply part of the proceeds to recruit an Individual Consultant to assist the AMR Technical Working Group of the One Health Coordination Platform to conduct a baseline Antimicrobial Resistance Knowledge, Attitude and Practice (KAP) Study that will establish benchmarks against the prudent use of antimicrobial agents in human health, animal health and the impact on public health among the population in Liberia.

The objective of the assignment includes, but is not limited to assessing the Knowledge, Attitude and Practice (KAP) on Antimicrobial Resistance (AMR) of prescribers in health facilities, commercial pharmacies, and veterinarians or farmers, and the impact on public health among the population. Also, to create a better understanding of the change in knowledge, attitudes and practices of AMR among human health, animal health and the environment.

The Consultant will provide quantitative and qualitative data per indicator of the survey as outlined in the objectives, and provide comparative data on prescribers, veterinarians/farmers, clients and owners of commercial pharmacies' perceptions of antimicrobial usage and resistance. Outline structural, systemic and environmental challenges limiting the effective conduction of the AMR survey within Liberia. Outline the extent of prescribers, veterinarians /farmers, clients purchasing OVER THE COUNTER (OTC) medication in commercial pharmacies and adults who are taking self-medication understanding in addressing the prevention and controlling of antimicrobial resistance in Liberia.
