- 5. A complete set of bidding documents in English will be sent to interested eligible bidders upon the submission of a written application to the address below. An electronic copy of the bidding document will be sent to each applicant free of charge only for those who submit written application letters. However, bidders are required to submit hard copies of their bids to the address mentioned below. Electronic submission from bidders will not be accepted.
- 6. Bids must be delivered to the address below on or before **Wednesday April 29, 2020, at 1:00** PM. Bid opening will be on the same day **at 1:00** PM. Electronic bidding will not be permitted. Late bids will be rejected. Bids will be publicly opened in the presence of the bidders' designated representatives and anyone who choose to attend at the address below.
- 7, All bids must be accompanied by the following listed below:
 - I. A copy of a valid business registration certificate;
 - II. A copy of current tax clearance certificate from the Government of Liberia.;
 - III. A bid security amount of 2% of the bid price and must be in the form of a Fund Guarantee;
 - IV. A copy of the PPCC's Vendor Registration Form (VRF) Receipt;
 - V. Article of Incorporation;
 - VI. Origin of Goods to be supplied;
 - VII. Guarantee schedule of delivery/Delivery Term;
 - VIII. Access to a line of credit or a Fund statement;
 - IX. Ability to pre-finance the supplies as Local Purchase Order is approved;
