- 1. The Government of Liberia is implementing a grant from the Global Agriculture and Food Security Program (GAFSP) and a loan from the African Development Fund (ADF) toward reducing rural poverty and household food insecurity by increasing income for smallholder farmers and rural entrepreneurs particularly women, youths and the physically challenged. The government of Liberia through the Smallholder Agriculture Productivity Enhancement and Commercialization (SAPEC) Project intends to apply part of the proceeds of this grant to payments under the contract for **The Supply of Laboratory Apparatus, Chemicals and Reagents.**
- 2. The supply include amongst others:
 - i. Supply more than 35 assorted laboratory apparatus of various sizes, technical complexity and requested quantities
 - ii. Supply more than 47 assorted chemicals of various composition and in requested quantities.
 - iii. Deliver, install, or Set up Laboratory Apparatus at designated point
