The Government of Liberia, through the Ministry of Agriculture, has received a support from the World Bank, for Smallholder Agriculture Transformation and Agribusiness Revitalization Project (STAR-P). The STAR-P seeks to increase agricultural productivity and commercialization of smallholder farmers for selected value chains in selected counties and intends to apply part of the proceeds for the recruitment of an individual consultant for the Development of Child Labor Policy Manual for the STAR-P.

#### Scope of Services

The STAR Project wants to hire an individual to undertake the proposed assignment. The Individual Consultant selected will conduct a quantitative and qualitative study of child labor in the fifteen Counties and report the findings and develop a policy for the PIU adherence. The scope of work to be performed by the individual include but is not limited to the following:

- Identify factors that are giving rise to, or driving child labor in the rice, oil palm, cassava, rubber and horticulture value chains and livestock rearing.
- Identify best practices that comply with ILO concerns.
- Collect quantitative data on child labor in rice, oil palm, cassava, rubber value chains and livestock rearing through an appropriate household survey of representative household heads
- Collect qualitative data using Focus Group and key informant Interviews in representative farming communities.
- Position the STAR-Project and RETRAP to prevent child labor in the agriculture sector, particularly in the above-mentioned value chains and livestock farming.

- Recommend measures for the protection of children from child labor and other form of abuses in the project targeted areas.
- Prepare a child labor policy in accordance with best practice.

The Ministry of Agriculture now invites eligible individual consultants to indicate their interest in performing the Services. ## Individual Consultancy to Conduct a Child Labor Survey in the Agriculture Sector and prepare a Child Labor Policy

#### 1. Background

The Government of Liberia received funding support of US\$48 Million from the World Bank and International Fund for Agriculture Development (IFAD) for implementation of the Smallholder Agriculture Transformation and Agribusiness Revitalization Project (STAR-P). The STAR Project is managed by the Ministry of Agriculture and seeks to Increase agricultural productivity and promote commercialization of smallholder farmers through productive linkage between the farmers and the private agribusiness firms in selected value chains. At its focus, the project will support the value chains of Rice, oil palm and Horticulture. The project is being implemented in Liberia over a period of five years and consists of the following three components: Institutional Capacity Building of Farmers, State and Non-State Organizations, Financial & Technical Assistance for Productivity Enhancement; and Project Management, Monitoring & Evaluation.

As part of its interventions, the STAR Project will contribute to enhancing productivity and commercialization of rice, oil palm and horticultural crops for smallholder farmers and agribusinesses across Liberia. To successfully achieve increase in production and productivity of the targeted crops, the STAR Project will support the introduction and adoption of various climate smart agriculture technologies and agronomic best practices geared at improving the output of smallholder farming systems. To facilitate this process, the STAR Project will contract the services of relevant firms to provide technical assistance for the transfer of site-specific agronomic farm management technologies to include various climate smart agriculture technologies and best management practices to various targeted smallholder farmers, farming groups and cooperatives across the country.

The selected individual will be tasked with developing the Child Labor Policy, Sensitization Plan and survey in the Agriculture Sector. This is intended to direct the Smallholder Agriculture Transformation & Agribusiness Revitalization Project (STAR-P), the Rural Economic Transformation Project (RETRAP) and the agriculture sector as a whole in adherence to the child labor regulations of the World Bank and ILO.

### 2. Objective of the Study

The objective of this individual consulting service is to conduct a quantitative and qualitative study on child labor in the 15 counties (to comply with ILO concerns and upholding best practice in meeting international standards of labor use).

### 3. Scope & focus of the Study

The study will identify practices in the agriculture sector nationwide, taking into considerations the gendered divisions of labor that comply with ILO concerns and those that do not. It will also determine the extent (if it is observed to be the case) of child labor practices in the workforce in areas where they are identified; recognize positive practices that help prevent child labor; establish push and pull factors driving child labor in the agriculture regions of interventions and propose recommendations for project implementation.

The Individual Consultant selected will conduct a quantitative and qualitative study of child labor in the fifteen Counties and report the findings and develop a policy for the PIU adherence. This study aims to:

1. Identify factors that are giving rise to, or driving child labor in the rice, oil palm,

cassava, rubber and horticulture value chains and livestock rearing.

2. Identify best practices that comply with ILO concerns.

3. Collect quantitative data on child labor in rice, oil palm, cassava, rubber value chains and livestock rearing through an appropriate household survey of representative household heads

4. Collect qualitative data using Focus Group and key informant Interviews in representative farming communities.

5. Position the STAR-Project and RETRAP to prevent child labor in the agriculture sector, particularly in the above-mentioned value chains and livestock farming.

6. Recommend measures for the protection of children from child labor and other form of abuses in the project targeted areas.

7. Prepare a child labor policy in accordance with best practice.
