The Smallholder Agriculture Transformation and Agribusiness Revitalization Project (STAR-P) addresses critical market failures limiting the development of rice, oil palm, and horticulture value chains. The project achieves its objectives of increasing agricultural productivity and promoting smallholder commercialization by facilitating private sector investment in selected value chains and by fostering productive links between smallholder farmers and selected agribusiness firms through a business climate lens. Adaptation approaches and mitigation measures are applied to rice and oil palm production to enhance climate resilience and minimize climate risks. The operative project development objective for STAR-P is to increase agricultural productivity and commercialize smallholder farmers for selected value chains in the various counties of Liberia.

## **ToR for the STAR Project Implementation Completion Report Consulting Services**

### 1. Background

The Smallholder Agriculture Transformation and Agribusiness Revitalization Project (STAR-P) addresses critical market failures limiting the development of rice, oil palm, and horticulture value chains. The project achieves its objectives of increasing agricultural productivity and promoting smallholder commercialization by facilitating private sector investment in selected value chains and by fostering productive links between smallholder farmers and selected agribusiness firms through a business climate lens. Adaptation approaches and mitigation measures are applied to rice and oil palm production to enhance climate resilience and minimize climate risks. The operative project development objective for STAR-P is to increase agricultural productivity and commercialize smallholder farmers for selected value chains in the various counties of Liberia.

The project design is based on three strategic pillars, which are prerequisites for efficient and competitive value chains: (i) Institutional development to address critical capacity and coordination gaps; (ii) enhancement of productivity, quality, and efficiency along the targeted value chains; and (iii) improvements in the enabling environment.

The value chains selected and supported under the project are based on a sector scan prioritizing the agribusiness subsector on various development impact and investor potential criteria, including job and income opportunities. Experts' analysis shows that the three value chains selected for intervention (rice, oil palm, and horticulture) have the most substantial potential for development impact, ease of implementation, and attractiveness for private sector investment.

The project consists of three components: (i) *Institutional capacity building and strengthening the enabling environment for farmers, state, and nonstate actors,* (ii) *enhancing productivity and competitiveness,* and (iii) *project management, monitoring and evaluation (M&E), citizens engagement, and contingency emergency response.* 

Initially, the scope of the Project covered five counties but extended and includes all 15 counties in Liberia. The project's direct beneficiaries are 38,000 smallholder farmers, of which at least 30 percent target women. These farmers benefit from increased income from productivity increases and improved market access to sell their products. Production and market access support are provided to rice, palm oil, and horticulture producers, resulting in productivity gains for all players along these value chains. The project benefits farmers within all counties in Liberia. Other beneficiaries include agribusinesses and business development services enterprises with good business links to smallholder farmers in the targeted value chains.

Under implementation and institutional arrangements, the Ministry of Agriculture, MoA, Liberia is responsible for overall project implementation. An inter-ministerial National Project Steering Committee (NPSC) headed by the MoA will provide project strategic oversight while a Project Implementation Unit (PIU) will be responsible for the day-to-day project execution. At the county level, project-financed County Focal Points (CFPs) will work with the County Agriculture Coordinators (CACs) and District Agriculture Officers (DAOs) to implement the project at the local level. The CFPs will report to the STAR-P's PIU with a copy of the reports provided to the office of the CAC.

The STAR Project since its effectiveness on June 28, 2019, has undergone several implementation support missions jointly undertaken by IFAD and the IDA, World Bank who are the funders of the Project. The Project September 2024 Implementation Support Mission, ISM Aide Memoire under implementation progress findings state the STAR project is making good progress towards its development objectives. The end-of-project targets for two of the key performance indicators have been fully achieved. The total number of direct project beneficiaries increased to 42,726 (against the target of 38,000) with women constituting 53% (22,645) against the 30% target. The mission maintained the performance rating for the progress towards achieving the PDO as satisfactory.

As the STAR Project approaches implementation closure, and in accordance with project management practice and principles and, in order to analyze the completion of the project indicators, the implementation effectiveness and the subsequent impacts and relevance, management efficiency and experience, further guide the development of follow-up projects, improve the management mechanism, improve the management level of the project, and at the same time, in order to further support the development and practice of similar undertakings, the project seeks to hire a suitable consultant to carry out project summarization, project performance evaluation, and project completion report.
