The Government of Liberia has received a loan from the International Fund for Agricultural Development (IFAD) to fund the Tree Crop Extension Project (TCEP). The Government intends to apply part of the proceeds of the TCEP loan for eligible payments under contract for the total construction of 49.172 km of roads in Nimba County.

1. The MoA/PMU/IFAD/TCEP project now invites sealed bids from eligible bidders for the construction of roads as indicated in the matrix below. Bidding will be conducted through the International Competitive Bidding (ICB) procedures as specified in IFAD's Procurement Handbook 2010 edition and Guidelines, and is now open to all eligible bidders as defined in the Procurement Guidelines.

- 2. A bidder can only bid for a maximum of two lots in the same district. Bids will be evaluated and contract awarded to the lowest and most evaluated responsive bidder for each lot.
- 3. Interested eligible bidders may obtain further information from the MOA/PMU/IFAD/TCEP Project Coordinator and inspect the bond bidding documents including the Maps, drawings and BOQs for the construction of these roads during office hours 0900 to 1600 hours, Monday through Friday at the address given below.
- 4. A complete set of bidding documents in English (Electronic/Hard Copy) can be obtained from MOA/PMU/IFAD/TCEP Project Procurement Unit, Libsuco Compound, Old LPRC Road, Somalia Drive, Gardnerville, Monrovia, Liberia for a non- refundable fee of \$200.00 USD beginning Monday, February 24, 2020 to Monday, April 6, 2020 from 09:00am to 16:00 pm daily, Monday through Friday.

5. All bids must be accompanied by the following listed below:

- I. A bid security amount of 2% of the bid price and must be in the form of a Bank Guarantee.
- II. A copy of a current business registration certificate in country of operation, A copy of current tax clearance certificate from the country in which they are registered;
- III. Experience and Technical capacity of bidder in similar works;
- IV. Power of Attorney duly signed and stamped;
- V. A list of recent contracts performed (at least two similar works) with evidence of completion;
- VI. A copy of the PPCC's Vendor Registration Form (VRF) Receipt or similar registration in the country of operation (Local Firm Only) and
- VII. A copy of the Ministry of Public Works classification certificate- Class (B0: B12) or similar document from the country of operation (Local Firm Only).
- 6. Site visit is scheduled for March 16th, 17th, 18th and 19th 2020 @ 10:00 AM based on the schedule above and shall be led by a representative of the MoA/PMU/IFAD/TCEP project. Site visit is mandatory. Pre-bid Meeting is scheduled for March 23, 2020 @ 1:00 PM All bidders are encouraged to attend the pre-bid conference.
- 7. Sealed bids must be delivered to the address below on or before **April 6, 2020 at 11:00 AM.** Electronic bids submission is permitted only for international bidder/bidders. Late bids will be rejected. Bids will be publicly opened in the presence of the bidders' designated representatives and anyone who choose to attend at the address below at 11:00 AM on the same day.
