The Government intends to apply part of the proceeds of the RCFP loan for eligible payments under contract for Procurement of a Banking Software
- 2. The IFAD/PIU, Ministry of Agriculture now invites sealed bids from eligible and qualified bidders for the Procurement of **Banking Software**:

Interested eligible bidders may obtain further information from Program Management Unit, Ministry of Agriculture Annex, Old LPRC *Road*, Somalia Drive, Gainesville, Monrovia, IFAD Project Coordinator and inspect the bidding documents during office hours 0900 to 1600 hours, Monday through Friday at the address given below
- 5. A complete set of bidding documents in English will be sent to interested eligible bidders upon the submission of a written application to the address below. An electronic copy of the bidding document will be sent to each applicant free of charge only for those who submit written application letters. However, bidders are required to submit hard copies of their bids to the address mentioned below. Electronic submission will not be accepted.
- 6. Bids must be delivered to the address below on or before to 10th September, 2020 at 2:00 PM. Electronic bidding will not be permitted. Late bids will be rejected. Bids will be publicly opened in the presence of the bidders' designated representatives and anyone who choose to attend at the address below at 2:00 PM on the same day.
- 7. All bids must be accompanied by the following:
 - A copy of a valid business registration certificate from any eligible country;
 - A copy of current tax clearance certificate from any eligible country
 - A bid securing Declaration
 - Article of Incorporation;
