



Letter of Invitation for Bid

Re: *Supply and Delivery of Rice Value Chain Inputs and Vegetable Value Chain Inputs*

1. The Government of Liberia has received (or in appropriate cases “has applied for”) financing from the International Fund for Agricultural Development (IFAD) and intends to apply a part of the proceeds of the financing to this procurement. The use of any IFAD financing shall be subject to IFAD’s approval, pursuant to the terms and conditions of the financing agreement, as well as IFAD’s rules, policies and procedures. IFAD and its officials, agents and employees shall be held harmless from and against all suits, proceedings, claims, demands, losses and liability of any kind or nature brought by any party in connection with *Building Climate Resilience Project* (BCRP).
2. BCRP includes an IFAD Grant of US\$ 8.840 million. The project will work towards developing a viable and sustainable smallholder cocoa Producers and Rice Producers in Bong County.
3. This invitation for bids (IFB) will appeared in *InProfile Daily* newspaper on January 22, 2026, and on the *Ministry of Agriculture website*.

The purchaser now invites sealed bids from eligible entities (bidders) for the provision of **the Supply and Delivery of Rice Value Chain Inputs and Vegetable Value Chain Inputs (Framework Contract 5 lots 2026-2027) - LIB/IFAD/BCRP/FMGC-01/26, PIU, Ministry of Agriculture Annex PMU, within 24 days**. More details on these goods and related services are provided in the schedule of requirements in this bidding document.

4. This IFB is open to all eligible bidders who wish to respond. Subject to restrictions noted in the bidding document, eligible entities may associate with other bidders to enhance their capacity to successfully carry out the procurement.

3. Bidding will be conducted using the **national competitive bidding (NCB)** method, the evaluation procedure for which is described in this bidding document, in accordance with the IFAD procurement handbook, which is provided on the IFAD website at www.ifad.org/project-procurement. The NCB process, as described, will include a review and verification of qualifications and past performance, including a reference check, prior to the contract award.
4. Please note that a pre-bid conference **will not** be held as described in the bid data sheet BDS, Section II of the bidding document.
5. Bids must be delivered to the address below and in the manner specified in the BDS ITB 25 no later than Monday, **February 16, 2026 1:00 PM**.
6. Bidders interested in submitting a bid shall send an Expression of Interest email to evah@moa.gov.lr Cc: swokpeh@moa.gov.lr requesting a softcopy of the bidding document. Bidding documents can be obtained by sending an email at or letter, giving full contact details of the bidder, to the following point of contact indicated below. 7. Bidders should be aware that late bids will not be accepted under any circumstances and will be returned unopened to the bidder. All bids must be accompanied by a bid security (as required) in the manner and amount specified in the bid data sheet.
8. Please note that electronic bids **shall not be accepted** as defined in ITB BDS 25.
