I. BACKGROUND

# 1. Background

The Government of Liberia, through the Ministry of Agriculture, has received funding from the World Bank, for the Rural Economic Transformation Project (RETRAP). The Objective of the RETRAP is to improve productivity and market access for smallholder farmers and agrienterprises in selected value chains (Rubber, Cassava, Livestock (Poultry and Piggery) Rice and vegetables in all 15 counties. The RETRAP under Sub-component 2.2 financed matching grants for smallholder farmers' organizations (FBOs), agribusinesses, processors, aggregators, and other participating partners. The Matching Grant (MG) scheme described under subcomponent 2.2 might trigger agricultural commercialization, expansion of farmlands, expansion and/or renovation of agricultural infrastructure such as warehouses, processing facilities, electricity connectivity etc. Agricultural intensification could trigger extensive use of pesticides with adverse repercussions on human health and biodiversity. Support to poultry and piggery industry will produce animal waste (manure) which could contaminate ground and surface water as well as contribute to green-house gas emissions if poorly managed. Similarly, effluents from processing facilities e.g., cassava processing under the MG scheme could contribute to water contamination, eutrophication and unsightly scenes in communities. Grants have been disbursed to approved grantees with sub projects implementation ongoing for in the last 20 months. All pose potential risks and hazards to people and the environment. The Ministry of Agriculture through the Project Implementation Unit is therefore commissioning an Environmental Audit to assess the implementation of project activities, and determine whether there were safeguards gabs, complaints or

grievances, conflicts and disagreements and whether there was a functional grievance redress mechanism in place to resolve conflicts. The outcome of this audit will inform the future project

#### **II. OBJECTIVES OF THE SERVICE / WORK**

The objective of the assignment is to assess the compliance with the Environmental and Social Framework (ESMF) and Environmental and Social Management plan prepared for the grantees for their sub projects implementation under the RETRAP. It will involve an assessment of the implementation of infrastructure/farm works; the nature and scale of works; the safeguard tools that guided the sub projects; monitoring, supervision and reporting of safeguards; and the functionality of the Grievance Redress Mechanism at the farm sites and any other related sites under the project establishment. The assignment includes the assessment of the project ESMF, Grantee ESMPs, GRM and other safeguards instruments implemented, including identifying incidents, fatalities, availability and functionality of GBV (Sexual Exploitation and sexual harassment (SEA/SH) referral pathway and service provision) workers induction and signing of GBV code conduct, if any, during implementation, document best practices, if any and suggest measures for effective implementation and monitoring.

#### **III. SCOPE OF THE SERVICES**

- ✓ Review the grantee ESMPs and identify the key mitigation measures and monitoring requirements and parameters during sub project implementation.
- ✓ Evaluate the use of the environmental social reporting templates, the monthly reporting, and use of ESIM
- ✓ Assess the social impacts particularly any loss of asset (land, trees and other assets on land), the mitigation measures and any outstanding issues by PAPs regarding loss of assets and compensation.
- ✓ Conduct site observations at locations where farm works are underway and at processing facilities to check that occupational health and safety and social measures and controls are operating as described and intended.
- ✓ To determine through field observations and consultations the impact of the processing works on ambient environmental parameters, such as noise, dust and air emission, water and soil pollution, washout of sediments and contaminants into wetlands, spills and leaks, wastes.
- ✓ Document incidents, accidents, fatalities
- ✓ Document investigation measures, referral pathway, service providers for managing GBV, including consultations of the communities and stakeholders
- ✓ Grievances and Complaints Documentation and Resolution
- ✓ Review and assess grievance and social incident register where these grievances are logged, investigated, and addressed?
- ✓ Assess the use of the Grievance Redress Mechanism / documentation and resolution of grievances.
- ✓ Assess the implementation of GBV action plan and check its functionality.
- ✓ Conduct stakeholder engagement with the project affected communities on the conduct of the grantees and the execution of farm work;
- ✓ Assess the major occupational and community health and safety noncompliances and propose corrective actions.
- ✓ Assess the efficacy of monitoring of implementation of grantee ESMP and identify shortcomings, if any, and identify areas for improvement.
- ✓ Prepare and present the findings (draft report) to the PIU. The report shall highlight constraints, if any during implementation; best practices, if any; areas requiring improvement in terms of implementation of mitigation measures indicated in the Management Plans and the extent of effective monitoring by

the PIU, etc., and suggest measures for effective implementation and monitoring of Management Plans. The audit report will be prepared based on review of the above document, site observations, compliance of the statutory requirements and interviews with stake holders.
