Assignment Title: Consultancy to recruit Business Development Service Providers (BDSP) for the STAR-P

The Government of Liberia *has received* financing from the World Bank toward the cost of the **Smallholder Agriculture Transformation and Agribusiness Revitalization Project (STAR-P)** and intends to apply part of the proceeds to recruit Business Development Service Providers (BDSP) to provide consulting services to the STAR-P.

The consulting services (“the Services”) include the following: (a) capacity building (training), coaching and mentoring; (b) development of trainings materials (modules); (c) training of MSMEs, Farmers’ groups, cooperatives to participate in the Matching Grant of the STAR Project; (d) providing coaching /mentorship skills to beneficiaries under the Matching Grant activity; and (e) facilitate MSMEs, FBOs and cooperatives linkages to standardization, regulatory, and compliance bodies in and outside Liberia through technical assistance.

The assignment will be contracted in three (3) separate lots for three separate contracts and a firm may apply for more than one lot. This REoI applies only to Lot 1. The remaining 2 Lots are being advertised separately.

(1) Lot 1: Lofa, Gbarpolu and Grand Cape Mount Counties.

The duration of contract is One (1) year renewable based on satisfactory performance.

The Ministry of Agriculture now invites eligible consulting firms (“Consultants”) to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating

that they have the required qualifications and relevant experience to perform the Services. The shortlisting criteria are:

- a) Detailed company profile indicating the Core Business of the firm and Number of Years in Business
- b) Technical and Managerial Organization of the Firm
- c) Description of Similar Assignments with considerable experience in technical assistance to MSMEs, Farmers' groups, cooperatives participating in Matching Grants. Experience in Similar Conditions particularly in post-conflict contexts in Africa.
- d) Availability of Appropriate Skills among Staff or within the firm

Key Experts will not be evaluated at the shortlisting stage.

The attention of interested Consultants is drawn to Section III, paragraphs, 3.14, 3.16, and 3.17 of the World Bank's "Procurement Regulations for IPF Borrowers" dated July 2016, revised November 2017, August 2018 and January 2020, setting forth the World Bank's policy on conflict of interest. A Consultant will be selected in accordance with the **Quality and Cost based Selection (QCBS)** method set out in the World Bank Procurement Regulations.
