To conduct continuous monitoring and evaluation of the effectiveness agricultural production in the region.

Demonstrated experience in farmer training, curriculum and training materials development, especially in rice, oil palm and horticulture production.

Scope of Services

The overall goal of the agronomist is to train and enhance small holder farmers' capacities on good agricultural practices and response to national, regional, and international market demands. Within this context the agronomist is expected to:

- Train farmers on good agricultural practices and soil conservations techniques.
- Provide technical support in the preparation of nurseries for raising seedlings.

Main Responsibilities

- Review and improve a detailed work-plan on production practices for the crops targeted by the project, developed in collaboration with farmers, processors, buyers;

- Propose agronomic and environmental implementation guidelines for the STAR-P

assemble or collate information on all seed varieties tested and approved previously in Liberia and facilitate the testing of new seed varieties; multiplication, adaptation testing and observation nurseries in farmers' fields during the growing period;

- Ensure the quality and correctness of data recording performed by field agents, county focal points and key farmers/farmer group leaders based on protocol/guidelines. Analyze the data to see the progress of crop production, and provide regular update to beneficiaries, buyers, government counterparts, the project team, and other stakeholders
- Train STAR-P county staff and other relevant staff as needed;
- Participate in the development of manuals on agronomic practices in Liberia.
- Jointly participate, with the environment and social safeguard officer, in environmental assessment of project activities in collaboration with the EPA.
