The RETRAP seeks to increase income of rural poor households through sustainable agricultural livelihood enhancements and improved rural access and agricultural marketing infrastructure services. As its focus, the project will support the value chains of cassava, Rubber, Poultry & Pig husbandry Vegetables. The project will be implemented in 11 of the 15 counties over a period of five years.

### **Background**

The Government of Liberia, through the Ministry of Agriculture, has received a support from the World Bank, for the Rural Economic Transformation Project (RETRAP). The RETRAP seeks to increase income of rural poor households through sustainable agricultural livelihood enhancements and improved rural access and agricultural marketing infrastructure services. As its focus, the project will support the value chains of cassava, Rubber, Poultry & Pig husbandry Vegetables. The project will be implemented in 11 of the 15 counties over a period of five years.

#### **Scope of Services**

The consultant will seek to actualize the commercialization objective of RETRAP with particular focus on value chains and agribusiness development, providing support to the identification and /or development of investment operations and related support policies.

### **Main Responsibilities**

Improve governance and partnerships across the selected value chains, and collaboration among agribusiness development programs/projects in the country. Perform analysis of selected agricultural sectors/food chains, including food nutrition and security and food safety issues and assess the feasibility of agribusiness investment proposals and the modalities applied to developing the RETRAP funded agriculture business.

Facilitate the transformation of the Marketing Division of the Ministry of Agriculture into a functioning Agribusiness Growth Delivery Unit (AGDU). Analyze the constraints and opportunities related to agribusiness investment options with emphasis on the functionality of markets, support services, trade policies, market institutions and organizations, risk management systems, food safety control systems and private sector engagement.

Identify and facilitate sustainable market linkages/platforms for smallholder farmers.

Assist in establishing public private engagement platforms for market-based value chain strategic planning.

Assist in promoting the conditions for private sector involvement in food and agriculture supply and value chains, producer organizations, civil society and pro-poor public private and public- private -community partnerships Identify and analyze agribusiness investment-related policy issues involving representatives of the private and public sector with a view to reach a consensus on improved policies.

Represent the PIU to the LACF investment committee and contribute to the business decision making process in the review of various business proposals. Formulate and deliver capacity development activities and programs to support private and public stakeholders in the areas of agribusiness, marketing and food chain development.

Prepare clear and concise reports to contribute to policy dialogue and other communication for development activities supported by the Project.

Develop suitable agribusiness financing models that also address climate related risks.

Consolidate the outcome of the above tasks and prepare development of strategies and action plans for agriculture commercialization in the selected provinces.

Support processes of integrating value chain related investments into medium-term investment plans and medium-term expenditure frameworks.

Support the development of climate responsive financing arrangements.

Propose a program to build capacity of government officials (i.e., an interdepartmental task force for facilitating agribusiness development, financial intermediaries, public-private platform stakeholders, and agribusiness entities.
