#### NATIONAL COMPETITIVE BIDDING

- 1. This Invitation for Bids follows the General Procurement Notice for this Project that appeared in *Development Business*, with **Reference No. AFDB80-05/12** posted **11th May 2012**.
- 2. The Government of Liberia is implementing a project with grant resources from the Global Agriculture and Food Security Program (GAFSP) and a loan from the African Development Fund toward reducing rural poverty and household food insecurity by increasing income for smallholder farmers and rural entrepreneurs particularly women, youths and the physically challenged. The Government of Liberia intends to apply part of the proceeds to payments under the Contract for the Supply of Fertilizers, Herbicides, Insecticides, Fungicides and Farming Inputs in Contract No: LIB/SAPEC/PMU/GC/NCB/001/2020.
