- 1. This Invitation for Bids follows the General Procurement Notice for this Project that appeared in *Development Business*, with **Reference No. AFDB80-05/12** posted **11th May 2012.**
- 2. The Government of Liberia has received a Loan from the Global Agriculture and Food Security Program (GAFSP) and a loan from the African Development Fund toward reducing rural poverty and household food insecurity by increasing income for smallholder farmers and rural entrepreneurs particularly women, youths and the physically challenged. The Government of Liberia intends to apply part of the proceeds to payments under contracts for the **Development of 170 Hectares of Lowland.**
- 3. The Program Management Unit (PMU) of the Ministry of Agriculture now invites sealed bids from eligible and qualified construction companies for the **Development of 170 Hectares of Lowland as indicated below:**

Bidding will be conducted through **National Competitive Bidding (NCB)** in accordance with the African Development Bank's *Rules and Procedures for Procurement of Goods and Works* (May 2008 Edition, Revised July 2012) and is open to all bidders from eligible Regional and Non-Regional member countries, as defined in the Guidelines. The provisions in the Instructions to Bidders and in the General Conditions of Contract are the provisions of the African Development Bank Standard Bidding Document: Procurement of Goods or Procurement of Works
- 7. Bids must be delivered to the address below on or before **December 8, 2017 at the hour of 1:00 PM local time.** Electronic bidding **WILL NOT BE PERMITTED.** Late bids will be **rejected**.
- 8. Bids will be opened in the presence of the bidders' representatives who choose to attend in person at the address below at the Main Conference Room of the PMU on December 8, 2017 at the hour of 1:00 PM local time.
