### NATIONAL COMPETITIVE BIDDING

1. This Invitation for Bids follows the General Procurement Notice for this Project that appeared in *Development Business*, with **Reference No. AFDB80-05/12** posted **11th May 2012**.

The Government of Liberia is implementing a grant from the Global Agriculture and Food Security Program (GAFSP) and a loan from the African Development Fund toward reducing rural poverty and household food insecurity by increasing income for smallholder farmers and rural entrepreneurs particularly women, youths and the physically challenged. The Government of Liberia intends to apply part of the proceeds to payments under the Contract for the **Supply of Reagents and Laboratory Apparatus for Tubman University with Contract No: LIB/SAPEC/PMU/GC/NCB/002/2020 in one complete Lot**.

1. The Program Management Unit (PMU) of the Ministry of Agriculture now invites sealed bids from eligible and qualified bidders for the **supply of reagents and laboratory apparatus** as indicated below:
