The Government of Liberia has received additional funding through its Rural Economic Transformation Project (RETRAP) from the World Bank to respond to current severe food and nutrition crisis in the country. This support is to preserve and strengthen the productive capacity of farming households to enable continued and expanded production of key staple foods, both for own consumption and the market. It will facilitate farmers' access to small-scale mechanization, including; machinery for land development, irrigation, production, harvest and post-harvest equipment (mini-combine harvester) and minimal means of transport (tricycles) to ease the laborious traditional agricultural production, particularly for women, and encourage vouth participation in the sector. The need to make processed agricultural commodity competitive, reduce import bills, promote and build entrepreneurship in rural communities in agribusiness, integrating farmers into the supply chain of rice, cassava, rubber, pig, poultry and vegetable with a focus on job creation and employment, food and nutrition security especially amongst women and youth will support the medium to long-term goal of the government, and intends to apply part of the proceeds toward payments under the contract for the Procurement of Service Provider for Agriculture Farm Land Preparations, Lots 1, 2 and 3.
