- ➤ Provides leadership, supervision, coordination and sustainable management of land and water resources in the assigned area.
- ➤ Promote efficient, sustainable, equitable and effective best management of land and water resources in the region.

#### **TECHNICAL DUTIES:**

- ➤ Maintain high level of technical and legal knowledge within all areas of sustainable land and water management including soil and water quality, biodiversity protection, and biosecurity management; to apply best practices to this work and communicate same to the stakeholders within the region.
- ➤ In collaboration with MOA Regional Team, regularly handle faceto-face negotiations with projects, partners, farmers, community groups and other stakeholders who may be strongly opposed to land and water sustainable best management practices adoption in the region.
