BACKGROUND

The Monitoring and Evaluation (M&E) Division of the Ministry of Agriculture is responsible for assessing the performance of agricultural programs and projects to evaluate their effectiveness, impact, and sustainability. Key functions of the division include Designing M&E frameworks and conducting regular evaluations; collecting beneficiary feedback and reporting on progress toward set targets; Providing input for sector planning, programming, and budgeting, including establishing performance targets and indicators; Conducting stakeholder and client surveys to assess service delivery and advising management accordingly; Coordinating mid-year and annual performance reviews and reports and Overseeing the collection, analysis, interpretation, and presentation of data. The division leads the tracking and reporting of performance, including progress on the National Agriculture Development Plan, Ministry of Agriculture projects, and the Ministry's targets outlined in the ARREST AGENDA FOR INCLUSIVE DEVELOPMENT (AAID).

Qualification & Requirements:

- ✓ Must have a master's degree or its equivalent in Monitoring and Evaluation, Agricultural Economics, Economics, Statistics, Development, Studies, or Public Administration/ Public Sector Management with at least 5 years of working experience with reputable institutions in and out of Liberia.
- ✓ Must also have an insight and in-depth understanding of other sectors associated with agriculture, food security, marketing, sector coordination, etc.
- ✓ Proven track record in designing and managing sustainable M&E systems.
- ✓ Significant understanding of agriculture value chain development and upscaling and rural development dynamics in developing countries.
- ✓ Experience using Open Data Kit (ODK) solutions and Data collection tools.
- ✓ Knowledge of Microsoft Excel and SPSS or STATA fundamentals is required.
- ✓ Expertise using common statistical software, analytics, and visualization tools (STATA, SPSS, R) is advantageous
